

GL EVENTS WINS THE CONCESSION FOR THE GRAND PALAIS EPHEMERE



Following an international call for tenders launched by Réunion des musées nationaux - Grand Palais and Paris 2024, GL events was selected as the concession holder of the project for the design, construction and technical maintenance of the Grand Palais Éphémère for the 2020-2024 period.

The *Grand Palais Éphémère*, a 10,000 sqm temporary structure will be installed on the site of the Champ-de-Mars landscaped public garden from early 2021 until the end of the Paris 2024 Olympic and Paralympic Games. This structure will host large events for the arts, fashion and sports, normally organised in the Nave of the *Grand Palais* exhibition hall and museum complex, during its renovation.

GL events selected the architectural firm, Willemotte & Associés, to design the *Grand Palais Éphémère* and to propose an exemplary eco-responsible structure meeting the most demanding environmental standards:

- Urban and aesthetic integration within the prestigious Champ-de-Mars site;
- Optimised use of materials with a significant place given to wood;
- Sound and thermal insulation for reduced energy costs;
- A modular construction design to facilitate subsequent reuse in multiple new forms and other locations.

This project is a testimony to GL events' extensive range of technical expertise (designing, producing and maximising the value of event structures). GL events and Jean-Michel Willemotte have also demonstrated a capacity for innovation that will allow them to produce a spectacular and iconic structure.
