## RESCHEDULING OF EXHIBITIONS TO BE HELD IN CHINA IN Q1 2020\*\*\*

In response to the current coronavirus outbreak<sup>1</sup> in China, our subsidiary, CIEC Union-GL events, postponed the three exhibitions scheduled to be held in Beijing in the first quarter of 2020 (end of February and early March 2020). These events should be postponed until at the earliest May and June 2020. Discussions are underway with the owner of the exhibition park (shareholder of CIEC Union - GL events) to determine the best dates to host the events.

In light of the level of space letting (90%) and receipts (85%) to date and the importance of these exhibitions for their sectors, the commercial teams expect the number of exhibitors rescheduling their participation to be significant and without an impact on the subsidiary's budget targets.

To date, the Group's other activities are not impacted by this outbreak because of the Chinese new year holidays.

GL events has decided to place the travel of its employees to Asia under surveillance. The Group is taking the necessary precautions with respect to its 500 local employees.

The Group thanks its employees in China for their availability and efforts over the Chinese New Year holiday vacation period to ensure the successful production of the events thus rescheduled.
